And whereas, in view of the above reconstitution of Board of trustees upon resignation of trustees & appointment of new trustees and for statutory compliance of the provisions of Income Tax Act in the Trust deed and for smooth administration and management of trust affairs, the Board of Trustees agreed and decided to amend/modify some of provisions of the aforesaid trust deed and trust board without changing the name of Trust, Nature of Trust , aims and objectives , etc.. and decided for registration of the Deed of Amendment of the trust deed before the Sub-Registrar, Cuttack.





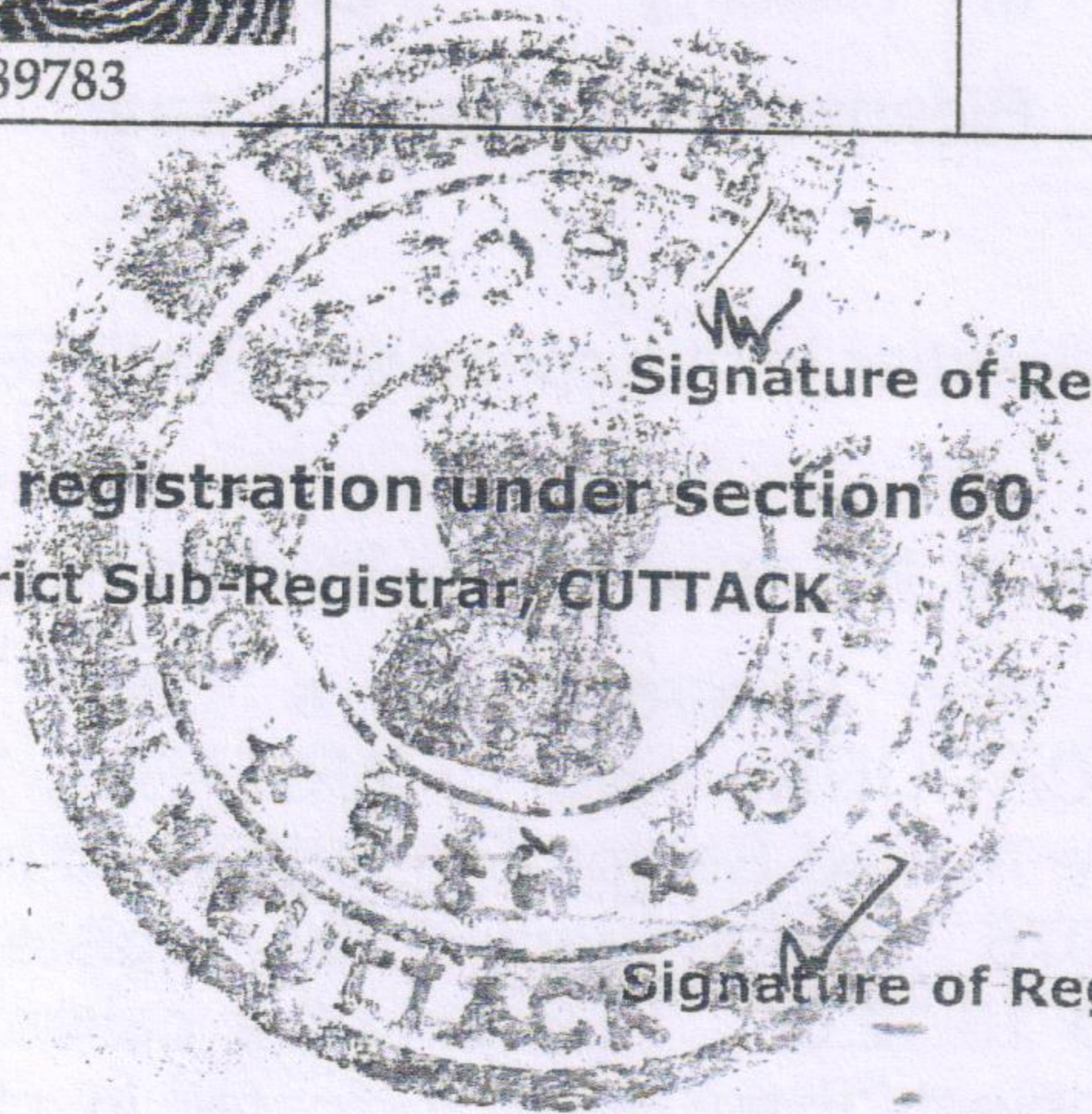

- A. And whereas, the benefits derived from the Trust is to be utilized for educational purposes as per the discretion of the trust board.
- B. And whereas, the trustees have agreed to act as TRUSTEES of these presents upon the terms and provisions hereinafter contained.

1. **NAME OF THE TRUST :**

The name of the Trust shall be: " **ST. XAVIER'S EDUCATIONAL AND CHARITABLE TRUST** "

2. **THE REGISTERED OFFICE OF THE TRUST :**




3. **AREA OF OPERATION :**

The trust shall be operated in the state and National level. No activities of the trust shall be carried out anywhere outside India.

4. **AIMS AND OBJECTIVES OF THE TRUST :**

- (i) To promote, advance and encourage primary, secondary and higher education and of knowledge in arts, science, literature, humanities and all other useful subjects in all their manifestations and other welfare centres .
- (ii) To open, establish, promote, set-up , run, Educational institutions such as Schools, English medium schools, Colleges, technical & professional colleges, also physical training, training of handicapped , fine art and other useful Arts , crafts among the public Industrial and cultural training centres and other establishments or institutions for advancement of education.
- (iii) To open, establish, promote, set-up , run, maintain, assist, finance, support lecture halls, boarding hostels, libraries, reading rooms, gymnasium and other training and vocational institutions.
- (iv) To set up, value oriented education such as master degree in computer applications, Bachelor Degree in information technology and Bachelor Degree in business management and other related courses of Universities or any other body under which the affiliation, recognition or approval will be obtained.
- (v) To organize voluntary health camps and seminars at the State, District levels.

- (vi) To promote scientific and appropriate Engineering , Technological education,. Training and research to ensure development and self reliance and to secure the future of the community.
- (vii) To establish ideal learning centres for all sections of the society to ensure a peaceful harmonious community with social safety and love and affection to each other with a broader sense or humanities citizenship and patriotism for National Building.
- (viii) To promote advancement up-liftment and improvement of the poor weaker communities.
- (ix) To take up relief and rehabilitation missions during natural disasters calamities and environmental hazards and to give, provide, and/or render help and assistance to and/or in any shape or form to the poor deserving and needy person.
- (x) To provide financial aid and assistance to other education institutions of similar object with this trust .
- (xi) To organize, undertake, conduct, maintain, facilitate and promote public awareness and programmes among the students, general public for protection, preservation of ancient monuments, cultural heritages, and archaeological structures and to provide for the prevention, control and abatement of environment.
- (xii) To acquire, take over, run, maintain and support schools, colleges, Study Circles and any other kind of Educational Institutions, residential or non-residential for imparting education of Primary, Secondary , higher secondary education, vedic sciences, modern sciences, Applied Sciences, Business and Commerce, Vocational, Medicinal, Engineering, Law, Arts, Architecture, Administration, Computer Sciences, Tourism, Journalism, Social services or any other disciplines.

5. BOARD OF THE TRUSTEES :

The Management and control of the Trust and Trust properties shall vest with the Board of Trustees. The Trust Board may appoint, select, elect, nominate new trustees in future and may increase or decrease the number of trustees in the Board of Trustees. But, the number of Trustees in the Board of Trustees shall be not less than 3(three) , nor more than 7 (Seven).

6. **BOARD OF THE HONORARY TRUSTEES/ADVISORS:**

The Board of trustees in its absolute discretion and pleasure may nominate any honorary trustee(s) to become and act as advisors of the Trust Board. The Advisors-trustees have no voting right. They shall not incur any right and liabilities of the trust and its affairs.

7. **TERMS OF OFFICE OF THE TRUSTEES:**

All the trustees, unless they voluntarily resign or otherwise decide, or become disqualified & in-eligible under these presents, shall continue to be the Trustees at the pleasure of the trust board during the term of their natural lives.

8. **APPOINTMENT OF NEW TRUSTEE:**

In case of death, retirement, resignation and/or permanent vacancy of the post of the Trustee, the trust board with the continuing trustees shall nominate, appoint any other person of their choice and satisfaction as the trustee of the trust in the place of the trustee so dying, retiring to do all such acts, rights and obligations conferred upon the new trustee in these presents.

9. **QUALIFICATION OF THE TRUSTEES :**

No person being-


- i) an undischarged insolvent ; or

- v) Possessed bad social reputation to the best knowledge of Board of trustees ;



- (f) If he/ she remains absent for long term of 3 years in the Trust Board meetings without permission of the trust board.

11. **POWERS AND FUNCTIONS OF THE TRUST BOARD :**

The management of the Trust shall exclusively vest with the TRUST BOARD . Without affecting the generally of powers and functions of the trust board to manage and administer the trust, the Board of Trustees shall have all power to control, manage and administer the trust and it's properties and to do all such acts as shall be deemed to be necessary, incidental and conducive to the attainment of the aforesaid objects under these presents, Save and except as provided herein above, the Board of Trustees shall exercise the following powers :

1. To take all policy decisions in respect of smooth management, Administration , development of the trust and it's properties.
2. To frame schemes and rules, regulations, bye-laws and issue circulars, notifications, corrigendum's, instructions, time to time to carry out the objects of the trust and for managing the affairs of the trust and otherwise for giving effect to the objects and purposes of the trust and to vary the same from the time to time as the Board of Trustees may in his discretion deem fit and proper.
3. The Board of Trustees shall be entitled at his discretion from time to time to start, discontinue, abolish and re-start any charity or any objective under this present or, to start, abolish, extinguish, revoke any charitable or educational institution .
4. To authorize any one or more trustee to hold any property(s) or any funds or any investment(s) of the trust in such manner provided under these presents and subject to such terms and conditions, limitations, rules and regulations as the Board of Trustees may form time to time think fit and proper.
5. To invest, to spend the Trust Estate , property (s), or any portion thereof either in the purchase of immovable properties, moveable properties, assets or of mortgage immovable properties, or in such manner as followed by law as may be in force from time to time and to convert, alter, vary, dispose of or transfer such investments from time to time.
6. To transfer, alienate permanently or temporarily the trust property or any portion thereof by way of sale, lease, license, mortgage, trust, will & etc. in favour any other trust, society, local body , charitable agency/organization, etc. having the same aim(s) and objective(s) and believing the same ideals mentioned in this presents on any terms and conditions as the Board of Trustees deems proper in order to implement any objects of this presents.
7. To manage or supervise the management of any lands, hereditaments, and premises for the time being comprised in the Trust Estate or any part thereof as he may deem fit in his absolute discretion.
8. To appoint Directors, Administrators, Secretaries, managers, lawyers, solicitors, auditors, Architects, Engineers, Surveyors , arbitrators or other employees, experts , office staffs for the purpose of management and supervision of the Trust Estate, for collection of rents, effects and


- 19. To borrow, if needed by way of loan, debt or otherwise through executing money bonds, agreements or any legal document or, otherwise, from any of the trustee (s) of these presents as may be necessary, for the benefit of the trust and for effectively performing the objects of the trust . - 20. To borrow, if needed by way of loan, debt or otherwise through executing money bonds, agreements or any legal document or, otherwise, from any person, firm, Company, Corporation, Society, Associations, Institution (s) or Public & Pvt. Trusts as may be necessary, for the benefit of the trust or for it's educational institution and for effectively performing the objects of the trust.
- 21. To accept , receive and/ or cause to receive any donation or contribution, grants in cash or in kind or in any form whatsoever from any person, trustee (s), firm, Govt., Company, Corporation, Society, Associations, club, Institution or trust for the furtherance of the objects of the trust or for any one or more of them upon such terms and conditions as the Board of Trustees may in his absolute discretion think fit and which are not inconsistent with the objects of the trust.
- 22. To pay all charges and outgoings in respect of any immovable property for the time being forming apart of the TRUST Fund and may incur all other costs, charges, and expenses incidents to the administration and management of the Trust Estate and the properties for the time being belongs to the Trust as the Board of Trustees may in his absolute discretion thing fit.
- 23. To grant financial assistance by way of loan, investment, aid, or otherwise to any other school, Educational institution(s), trust, association, societies, etc out of the trust fund.


12. MEETING OF THE TRUST BOARD :

13. POWER AND FUNCTION OF THE CHAIRMAN :

Upon approval of the Trust Board, the Chairman may borrow if needed without or against the security of the assets of the trust by way of bank overdrafts, loan or otherwise, as may be necessary, for the benefit of the trust from any financial agency, banks, cooperative societies, cooperative banks, and for more effectively carrying out the objects of the trust.
6. To appoint, remove, terminate, suspend the paid and honorary employees, volunteers, workmen, staffs of the Trust in consultation of the Board of trustees.

14. POWER AND FUNCTION OF THE CHIEF MANAGING TRUSTEE :


1. The Chief Managing Trustee, in absence of the Chairman shall preside over the meetings of the Trust Board.
2. To convene all meetings and shall cause minutes of all proceedings and resolutions of all such meetings to be correctly recorded in a book specially provided for the purpose.



3. To Conduct all correspondences of the Trust in conformity with the decision of the Trust Board .
4. To keep all its records, documents and properties of the trust and shall preserve them/those in safe condition.
5. Shall be a bank signatory in all bank accounts of the trust and school and educational institutions .
6. To Deposit all moneys as and when received from any source in to the accounts of the Trust with the Banks
7. To Prepare every year the annual report on the working of the Trust after getting that duly approved by the Trust Board
8. To Cause the accounts of the Trust to be duly audited by the appointed Chartered Accountant or Approved Auditors .

11. Upon approval of the Trust Board, to invest the Trust Estate, property (s), or any portion thereof either in the purchase of immovable properties, moveable properties, assets or of mortgage immovable properties, or in such manner as followed by law as may be in force from time to time and to convert, alter, vary, dispose of or transfer such investments from time to time.
12. Upon approval of the Trust Board, the Chairman may borrow if needed without or against the security of the assets of the trust by way of bank overdrafts, loan or otherwise, as may be necessary, for the benefit of the trust from any financial agency, banks, cooperative societies, cooperative banks, and for more effectively carrying out the objects of the trust .
13. To make all payments of the Trust against necessary bills and vouchers.
14. To Deposit all moneys as and when received from any source in to the accounts of the Trust with the Banks and to cause withdrawal of money jointly with any other trustee as decided by the Board of Trustees.

15. **POWER AND FUNCTION OF OTHER EXECUTIVE TRUSTEES :**

In addition to the duties assigned to them by the Board of Trustees from time to time, the trustees will generally assist the Chairman/ Secretary in the management and administration of the Trust Properties and activities. In such case, the concerned trustee shall do all the acts in all diligence for carrying out his duties to the best interest, benefit and welfare of the trust.

16. **QUORUM :**

Three of the Trustees shall form a quorum for any meeting of the Trust Board. Notice of the meeting of the trustees and all communications may be sent to the trustees at their addresses for the time being in the records of the trust.

17. **BANK ACCOUNT MANAGEMENT :**

The Board of trustees may from time to time open and maintain in the name of the trust/ college/school any banking accounts with such scheduled banks or nationalized banks, or cooperative banks, private banks or other approved banks as may from time to time and shall forthwith pay or cause to be paid the rents, incomes, earnings, savings, dividends and other receipts like grants, donations, certificates, etc and all other moneys forming part of the trust fund to the credit of any such account or accounts.

Generally, all Bank accounts of the trust and/or of educational institutions/schools/college run by the trust are to be opened and operated either by the Chairman & Chief Managing Trustee jointly. The Board of Trustee in its absolute discretion can change the signatory(s) of the Bank accounts in case of circumstances so needed.

18. **ACCOUNTS AND AUDIT :**


The Chief Managing Trustee in consultancy with the Trust Board shall maintain regular accounts of the trust / educational institutions.


All the accounts of the trust and the educational institutions runs under the trust shall be duly audited by a qualified Chartered Account or Firm of chartered accountants.

Sec. 12-A, Sec. 80-C,80-G of Income Tax Act & other provisions of Income Tax Act is applicable to this trust and this trust is entitled for the benefits of various exemptions under Income Tax Act, 1961, Gifts Tax Act, 1956, Wealth tax Act, 1957 or any other Act.

19. **FINANCIAL YEAR :**

Every year, the accounts shall be closed by 31st March. The Financial year of the Trust shall close on 31st March, of the succeeding years.

20. INVESTMENT OF TRUST FUNDS :

The funds of the trust shall be invested in accordance with the provisions of section 13(1)(d) read with section 11(5) of the Income Tax Act, 1961.

23. INDEMNITY TO THE TRUSTEES :

The Trustees shall not be answerable or accountable to acts, receipts, neglects and defaults done by any other trustee, any bankers, broker or any other person with whose or into whose hands the trust money or securities may be deposited or come in accordance with these presents nor for the deteriorations or, damage or, loss, of any stocks, funds, deposits, or securities nor for any defects or insufficiency of title or for any other losses unless the same shall happen by his own act, negligence.

24. POWER TO AMALAGAMATE OTHER TRUSTS, ETC. :

The Trustees may join, cooperate and amalgamate the trusts created by these presents or any portion thereof with any trust or institution having allied and or similar objects upon such terms as he may in his absolute discretion think fit. The trustees shall be at liberty to allow and permit any other trust, institution of charity in any local area (s) whose objects are the same and similar to those of these presents, to join, cooperate , assist, help and amalgamate the trust of these presents upon such terms as he may in his absolute discretion think fit.

No discrimination shall be permitted therein on grounds of religion, caste, creed or sex . It is further declared that all the incomes, earnings, moveable or immovable properties of the trust shall be utilized and applied for promotion, development and implementation of it's aims and objects as set under these presents. No trustees of the trust shall have any personal claim on any moveable or immovable properties of the trust or make any profits, whatsoever by virtue of trust. The educational institutions of the Trust shall work in conformity with the Government Rules & Regulation.


27. **RESIDUARY POWER :**




33. **INHERENT POWER OF SETTLOR :**






